The WV Board of Examiners of Psychologists thanks you for your exceptional work during COVID-19 Crisis, an unprecedented time. You are an essential part of our state's and nation's foundation for success, and we couldn't be prouder to serve alongside you. We are sharing the following message from the West Virginia Joint Interagency Task Force (JIATF) on COVID-19 Vaccines. We will be working hand-in-hand with the JIATF to provide information, determine correct allocation figures, and any other needs through this process.

**Message from the WV Joint Interagency Task Force (JIATF)**

JIATF states that Psychology Board licensees and supervisees will be recipients of the COVID 19 vaccine in the coming weeks, based on the State of West Virginia's allocation plan. The JIATF on COVID-19 Vaccines appreciates your patience with this process. West Virginia pandemic leadership and those at the JIATF are working to equitably and efficiently distribute COVID-19 vaccines to all who choose to receive it.

There are a number of factors that have guided the state's decision-making on the overlapping phased approach for vaccine distribution, which includes recommendations outlined by U.S. Centers for Disease Control and Prevention (CDC), Advisory Committee on Immunization Practices (ACIP), and our own epidemiological state data. The principles in decision making for allocating the limited supplies of vaccines include protecting the most vulnerable West Virginians, reducing hospitalizations, reducing the rate of deaths, and ensuring the state and local communities can maintain critical services including our acute healthcare system.

The pandemic leadership for the State of West Virginia understands the vital role you play in maintaining our economy and the critical functions that keep West Virginia going. As such, we are providing the Psychology Board with clear and concise guidelines for the vaccine allocation process.
