LICENSURE REQUIREMENTS - Starting in 2018

DOCTORAL DEGREE REQUIREMENTS

Please note that supervision must occur in WV with a WV approved supervisor and WV employment as a W-2 employee.

EDUCATION

- 1. <u>Doctoral Degree Applicants</u> must possess a Ph.D. or Psy.D. or an Ed.D. in a clinical form of psychology. Degrees are granted by an accredited institution of higher learning, the degree must have been completed in a department of psychology, a department of educational psychology, a department of education and psychology, or in a university department with the official designation containing the words "psychology" or "psychological."
- 2. <u>Accredited Graduate Degree Granting Institutions</u> must be accredited by one of the six nationally recognized regional accrediting agencies which include: North Central Association of Colleges and Schools, Western Association of Schools and Colleges, Southern Association of Colleges and Schools, New England Association of Schools and Colleges, Northwest Association of Schools and Colleges, Middle States Association of Schools and Colleges.
- 3. <u>Required Core Graduate Level Course</u> work includes, but is not limited to, all of the following areas: clinical interviewing, diagnosis and treatment planning, psychopathology, biological bases of behavior, ethics, assessment of children and adults, individual psychotherapy, clinical practicum, clinical internship, and tests and measures.

APPLICATION REQUIREMENTS

- 1. <u>Application:</u> If your credentials meet the above cited criteria, contact the Board office for an application. All application materials and fees listed on the appropriate check list must be submitted for Board approval. Email: psychbd@wv.gov
- 2. <u>W-2 Employees:</u> All doctoral level supervised-psychologists must be W-2 employees. Evidence that the supervised psychologist is or will be employed in this way must be submitted with the application.

SUPERVISION

- 1. <u>Gold Card</u>: Once approved, applicants will be issued a "Gold Card" which denotes that they are Board approved supervised psychologists. It also designates the Board approved supervisor(s) for the supervised psychologist. This card has an expiration date. It must be renewed on an annual basis via submission of a renewal form, continuing education certificates, CE Audit Form, and a fee.
- 2. <u>Adherence to Supervision Contract:</u> Supervised-psychologists and their supervisors are expected to complete supervision in accordance with the tenants of the contract.

- 3. <u>Supervision Required with Internship of 1,800 Hours or More:</u> If the candidate completed a pre-doctoral internship which meets the requirement of at least 1,800 hours, she/he will be eligible to sit for an oral examination upon successful passage of the EPPP, submission of quarterly reports, and submission of oral examination materials. Once these tasks have been completed, she/he will be scheduled for the next available oral examination.
- 4. <u>Supervision Required With Internship:</u> Doctoral degree applicants are required to complete one year of supervision if they completed a pre-doctoral or post-doctoral internship approved by the American Psychological Association (APA) or arranged through a program of study at an accredited institution of higher learning.
- 5. <u>Supervision Required Without Internship:</u> Applicants who have not completed an internship are required to complete 2 years of supervised practice.
- 6. <u>Quarterly Reports:</u> Supervised-psychologists are required to submit quarterly reports to the Board office 4 times per year. Additional information will be provided once an application is approved. Quarterly reports include face to face supervision and psychology work hours completed by the supervisee. Supervisors are also required to keep a supervision log, see the supervision contract for details.
- 7. **Continuing Education:** 10 hours of continuing education per full year is required for renewal of gold cards, 1.5 hours must be in ethics.

EXAMINATIONS

- 1. **EPPP:** Doctoral degree supervised psychologists must pass the EPPP within two (2) years and shall only take the EPPP a maximum of five (5) times during the 2-year supervision period. Those who fail to pass the EPPP within the designated periods will no longer be eligible for licensure. Those that do not meet this requirement must cease all psychological practice and must stop using the title of "Supervised-Psychologist."
- 2. <u>Oral Examination:</u> For those with an 1,800 hour approved internship these candidates are eligible to sit for an oral examination after passing the EPPP. For those who are being supervised, after completing the required years of full time supervised work and the required number of face-to-face supervision hours, doctoral degree supervised-psychologists are eligible to sit for an oral examination. Upon successful passage of the oral examination a WV psychology license will be issued to the candidate.
